Invitation of Public Commets

Sub:- Issue of access permission for construction of an approach road to the proposed new Commercial building at survey No.1882,1888 and 1890 of Kadakampally Village, Thiruvananthapuram Taluk,Thiruvananthapuram, District,Kerala at Km.6/429 (RHS) on NH-47 (New NH-66) of Kerala State by M/s Lulu International Shopping mall Pvt.Ltd., Edappally,Kochi, Kerala State-reg.

This office vide letter dated 22.09.2016 (Annexure-I) has accorded provisional NOC for construction of access to the above mentioned Commercial building (Three Access) with a condition to complete the construction as per approved drawings and furnish the completion certificate from the field authority within one year from the date of issue of provisional NOC. Further, owner of the commercial property vide letter dated 20.09.2018 has sought Two years extension for completion of the construction work.

- 2. Now, the applicant M/s Lulu International Shopping mall Pvt.Ltd., Edappally, Kochi, Kerala vide letter dated 20.09.2018 (Annexure-II) addressed to this office has sought extension of time for constructing the access to the above mentioned Commercial building for two years (i.e. up to 20.09.2019) citing the reason that the project which was scheduled for completion on 21.09.2017 has delayed due to scarcity of materials, bad weather and due to the work in progress on NH 66.
- 3. Since, the extension of time sought is more than 2 years from the date issue of provisional NOC, the proposal comes under relaxation category with regard to the non compliance of time frame for the construction of access to the above Commercial building. As per the guidelines, issued by the Ministry vide O.M. No.RW/NH-33023/19/99-DO III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments, and the comments will be invited within 60 days from the day of uploading in the format enclosed as Form 'A'.
- 4. In view of the above, comments of the public on the above relaxation proposal is invited to the below mentioned address:


