1. The subject proposal is requesting permission for Pole Erection of 33KV lines along the Road from Km.205/581 to Km.205/761 (LHS & RHS) and crossing at Km.205/761 With 2 Nos of Mini Towers for total length of 421m & total no. of poles 8 No's in the project stretch of Trichy to Kallagam Section of NH-81(Old NH-227) in the State of Tamil Nadu.
2. M/s. Droog Estate Private Limited, Coimbatore has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given.
