- 2. The subject proposal was submitted on Ministry's website on 10.07.2019 and was sent vide this office letter dated 18.07.2019 to EE, NH Division, Bharuch for examination.
- 3. As per inspection report submitted by concerned EE, NH Division, Bharuch it is noted that the case is meeting all the parameters of the guidelines except for the criteria of railway level crossing which is at distance of 740 m against 1000 m. and no fuel station exist within 2 KM from proposed fuel station. Therefore, the Executive Engineer, NH Division, Bharuch vide his letter no PB/2553/2019 dated 03.09.2019 advised to apply the case for relaxation as per MoRT&H Guidelines.

Further, the oil company vide letter dated 13.09.2019 has asked this office to consider case as per relaxation in guidelines for access permission along National Highway circulated vide letter no. RW/NH-33023/19/99-DOIII dated 16.03.16.

- 4. In view of the above, comments of public, (if any) on grounds of road safety and inconvenience to road user, on the above mentioned proposal is invited on below mentioned address/ Email address.



SUB: Access Permission And Approval For Approach Road For Proposed New Retail Outlet Abutting On Nation Highway-953, At Chain Age 02+286 Km, Right Hand Side (Between Km 02+257 Km To 02+316 Km), Block/Survey No. 13(Old-9), At Village:-Chapavadi, Tal:-Songadh, Dist:Tapi, Gujarat.

This is to certify that I, Executive Engineer, N.H. Division, Bharuch has inspected the Proposed New Retail Outlet Abutting On Nation Highway-953, At Chain Age 02+286 Km, Right Hand Side (Between Km 02+257 Km To 02+316 Km), Block/Survey No. 13(Old-9), At Village:- Chapavadi, Tal:-Songadh, Dist:Tapi, Gujarat on dated .....3.1.4.4.01.6

- 1. This Fuel Station is located on Hilly/Mountainous Terrain.
- 2. The National Highway 953 is Un-divided highway.
- 3. The distance of the nearest rural road from proposed fuel station is 714m, minimum distance required is 300m, therefore satisfies the MoRTH norms and circular.
- 4. The distance of the nearest fuel station from proposed fuel station is 2300m, minimum distance for un-divided carriageway required is 300m, therefore satisfies the MoRTH guidelines.
- 5. The general ground level of the proposed fuel station is 30 cms. below the level of the edge of the shoulder which is sufficient for adequate drainage.
- 6. The construction of proposed retail outlet has not commenced.
- 7. In this proposal of fuel station, the norms of minimum distance of the intersection from the road with NHs,SHs, minimum distance required is 1000.00 M, NH/SH/MDR/CityRoad are at 2300m for the subject location, therefore satisfies the MoRTH norms and circular.
- 8. Distance from Check barrier/ Toll Plaza/ Railway level crossing) is at 740m, against 1000m of MoRTH Guidelines, but at this location there doesn't exist a Fuel Station within 2Kms. So, it is adviced to apply for Relaxation as per MoRTH Guidelines.
