Invitation of Public Comments

Sub:- Issue of Access permission for construction an approach road to the proposed new Petrol / Diesel retail outlet in Survey No.64/3-10,67/2,90/3-5(Resurvey No.69/3A,69/3B2,69/3B) of Elathur Village, Kozhikode Taluk, Kozhikode District at Km.236/707(RHS) on NH-17(New NH-66) of Kerala State by M/s Essar Oil & Gas -reg.

This office vide letter dated 08.02.2016 has accorded provisional NOC for construction of access to the above mentioned retail outlet with a condition to complete the construction as per approved drawings and furnish the completion certificate from the field authority within one year from the date of issue of provisional NOC. Further, Oil Company vide letter dated 04.02.2017 has sought one year extension for completion of the construction work. Based on the details furnished by M/s. Essar Oil & Gas Limited this office has accorded the extension of time for construction of access to retail outlet up to 07.02.2018.

2. Now, the applicant M/s. Nayara Energy Limited (Formerly Essar Oil & Gas Limited) vide letter dated 24.01.2020 addressed to this office has sought further extension of time for constructing the access to the above mentioned retail outlet up to 07.02.2021 citing the reason that delay in obtaining various approvals for the execution of proposed fuel station also scarcity of materials and labour for construction.

3. Since, the extension of time sought is more than 1 years from the issue of provisional NOC, the proposal comes under relaxation category with regard to the non-compliance of time frame for the construction of access to the above retail outlet. As per the guidelines, issued by the Ministry vide O.M. No.RW/NH-33023/19/99-DO-III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments, and the comments will be invited within 60 days from the day of uploading in the format enclosed as Form 'A'.


