Further, Oil Company vide letter dated 04.02.2017 has sought one year extension for completion of the construction work. Based on the details furnished by M/s. - 2. Now, the applicant M/s. Nayara Energy Limited (Formerly Essar Oil & Gas Limited) vide letter dated 24.01.2020 addressed to this office has sought further extension of time for constructing the access to the above mentioned retail outlet up to 07.02.2021 citing the reason that delay in obtaining various approvals for the execution of proposed fuel station also scarcity of materials and labour for construction.
