OFFICE MEMORANDUM

Sub: Furnishing proposals of road safety engineering works on National Highways for Road Safety Annual Plan 2017-18 – Reg.

Improvement of road safety at critical locations through engineering measures is an important activity towards reduction of present high rate of accidents/fatalities on NHs. Towards this objective, it has been decided to prepare a separate Annual Plan for Road Safety Engineering works for effective preparation of proposals and their implementation.

2. Road safety improvement works for Annual Plan need to be selected carefully which would substantially reduce the accident potential through engineering improvements. To facilitate this objective, a Checklist of parameters to be met for inclusion in Road Safety Annual Plan has been prepared and enclosed at Annexure. It is requested that a list of 2 to 4 road safety engineering improvement proposals on National Highways from each State/UT may be identified and proposed in consultation with R.O., MoRTH for inclusion in Road Safety Annual Plan 2017-18. This list may please be furnished latest by 10th March, 2017 to Chief Engineer (Road Safety) at email ID : ce.rsce.morth@gmail.com. As the Road Safety Annual Plan is being separately prepared and handled, no road safety works should be included in the General Annual Plan for NH(O) works.
