AMENDMENT TO DEBARMENT ORDER DATED 17.06.2025

- 1. The Ministry of Road Transport and Highways, vide its Order No. CE-RO/LKO/In-Princ. iple Approved NH-91A, 92, 97 & 28B/UP/2016-17/550 (Pkg-V) dated 17.06.2025, had imposed penalty to the tune of 5% of Contract value of the Consultancy work and also debarment for a period of one year from all works of NHPWD/MoRTH/NHAI/centrally sponsored works in accordance with clauses 7.3 and 7.4 of Contract agreement.
- 2. M/s Redecon India Private Limited, by way W.P.(C) 11660/2025 and CM APPL. 47727/2025 tilted as REDECON INDIA PRIVATE LIMITED versus UNION OF INDIA & ORS., impugned the debarment order dated 17.06.2025 before the Hon'ble High Court of Delhi at New Delhi. The Hon'ble High Court vide its judgement order dated 06.08.2025 has passed the following direction:
 - "29. In the meantime, till the next date of hearing, in view of the aforesaid circumstances, there shall be a stay of the impugned debarment order dated 17.06.2025."
- 3. In view of the judgement dated 06.08.2025, the debarment order dated 17.06.2025 is amended to the effect that the debarment and penalty imposed on M/s Redecon India Private Limited vide this Ministry's Order dated 17.06.2025 shall not be given effect to during the pendency of the above.
