Subject: - Online permission for single unit ODC/OWC consignment on Modular Hydraulic Trailers (HT-1 to HT-13) on National Highways in the country.

Ref: Ministry's letter of even no. dated 17.01.2024

Sir,

Ministry has issued guidelines on the subject matter vide letter under reference above, and as per para 8 of the aforesaid circular "Maximum height of the motor vehicle with such ODC/OWC consignment shall be 4.75 m".

2. The aforesaid dimension has been decided based on rule 93 of CMVR, 1989 which provides for overall permissible height of 4.75 m of ODC over Modular Hydraulic Trailers above road level. 5.5 m vertical clearance has been specified for overhead structures across National Highways considering 0.75m vertical clearance as a safety margin for the structures.

3. In this regard, representations have been received from stakeholders to review aforesaid dimension as several consignment of overall height more than 4.75 m are required to be transported in the country.

The matter of grant of permission for OWC/ODC vehicles having consignment of overall 4. height more than 4.75 m has been examined and it is decided that ROs of the Ministry and structures, overhead upload the (NHAI/NHIDCL/etc) shall Executive Agencies RuB/FoB/Underpasses under their jurisdiction on Ministry's OWC/ODC Portal (www.morthowc.nic.in) and shall update the same. For grant of permission for vehicles having consignment of overall height more than 4.75 m, the applicant shall select the route on aforesaid web portal in such a way that RuBs/FoBs/overpasses are avoided in the route or the permission will be excluding the RuBs/FoBs/overpasses for which the applicant shall make diversions for movement of ODC/OWC.
