Sub: Updating of the construction cost considered in the B.K. Chaturvedi Report.

As per the current practice, the projects on PPP basis are appraised by Public Private Partnership Appraisal Committee (PPPAC) for approval. These projects are referred to Standing Cost Committee prior to referring them to PPPAC in line with the direction of Secretary (Finance) vide D.O.No. 2A/9/2010-PPP dated 26/08/2010.

2. The B.K. Chaturvedi Committee Report was prepared in August, 2009. Since then, the costs have escalated and, therefore, the average unit cost considered in the B.K. Chaturvedi Report is required to be updated. In the EFC meeting chaired by Secretary (Finance) on 22.01.2013, it has been decided that for such revision, the increase in prices based on the inflation index between the time the B.K.Chaturvedi Report was finalized and the present should be factored in.

3. Accordingly, based on Wholesale Price Index (WPI), the cost norms recognized and captured in the BKC report are now being updated as under :-
