Sub: Submission of Revised Cost Estimates to IFD - regarding

It has been observed from the RCE Proposals received in the Finance Wing from the RW that often adequate justificatory/explanatory details are not available in the file. In some cases, Reports of ROs are not enclosed either.

2. To enable IFD to process the proposals appropriately, RW is advised to ensure the following:

- (i) The RCE should be sent within a reasonable time to the Ministry.
- (ii) The ROs **Report with specific recommendations** on each and every item of work, where variation is involved, after a site visit, should be provided.
- (ii) All documentary evidence/supporting documents/Guidelines of State Government owing to which there is increase in costs/which are relevant to the calculation of the RCE should be provided.
- (iii) In proposals relating to LA estimates, including compensation for crops, horticulture, structures, private land, common land, forest land, tree cutting etc. requisite details like the list of items covered under one category for which compensation is sought, the no.
 of beneficiaries for each category, the name and addresses of the beneficiaries, the basis of calculation for the rates proposed item-wise/category wise, the clearance from Ministry of Environment & Forests, wherever applicable e.g. in case of tree cutting etc should be provided in a tabular form.
 - Detailed reasons as to why the above facts were not anticipated at the time of preparation of DPR/Feasibility Study should be provided.
- (vi) If the RCE is on account of lapses on the part of the Consultant/Officials, whether responsibility has been fixed and action that is proposed against the erring persons should be spelt out clearly.

(vii) An abstract of Cost Comparison, as per the format enclosed, may also be provided.
