It is brought to the notice of all that Mr. Rakesh Kumar Vidyarthi was selected as Resident Engineer by, M/s MSV International Inc. in Association with M/s Sterling Indo Tech Consultants Pvt. Ltd. for the work of "Consultancy Services for Authority's Engineer for Supervision of "Construction of 2-Lane Road of Potin-Pangin section of NH-13 (Package-B) (Design Chainage from Km 117.560 to Km 247.050) on EPC mode in the state of Arunachal Pradesh under Arunachal Pradesh Package of SARDP-NE".

2. The Authority's Engineer vide letter no MSV-SITC/MoRth/AP/P-P Pkg-B/2025-26/1157 dated 22.07.2025 has informed that Mr. Rakesh Kumar Vidyarthi has discontinued his services on the project due to personal reasons. He has not adhered to his contractual obligations and disengaged from the project unilaterally. He was deployed on the project site after approval accorded by the Authority vide letter no. SARDP-NE/P-P/Pkg-B/NH-13/Ar.Pr./PWD/2018-19/116/AE/RO-Ita/14215-17 dated 16.12.2024.

3. Therefore, as per stipulation of the GCC clause 4.5.6 of Contract Agreement and as recommended by the Authority's Engineer, Mr. Rakesh Kumar Vidyarthi is hereby debarred/blacklisted from participation in future projects of MoRTH (including all agencies of MoRTH) for a period of 2 years from the date of issue this notice.
