Subject: Deployment of key personnel of various consultancy assignments inter alia during feasibility/ DPR.

The deployment of various key personnel as per the provision of consultancy assignment is not only the contractual requirement but also essential for delivery of a good quality feasibility / DPR / consultancy report. It has been noticed in some consultancy work that key personnel, as approved and finalized during technical negotiation are not being fielded by the consultant which is resulting into delay in the delivery of consultancy report and also affecting the quality of the services.

2. The requirement of the key personnel at site /office are generally specified in the TOR / contract agreement and the implementing agency is required to ensure the deployment of the Key personnel in the field and in design office as per provisions of the contract agreement.

3. Accordingly, it is reiterated that the provisions given in the consultancy agreement regarding availability of the key personnel and preparation of the quality DPR are to be ensured invariably. In case any implementing agency observe non-availability of the key personnel, action is to be taken as per the provisions of the consultancy agreement for non performance of the firm as well as the key personnel

and a report is to be furnished from time to time to the Ministry. Defaulting firms as well as key personnel may also be notified as nonperforming who will not be considered for future assignment till they cure the default.
