Whereas, the Executive Engineer, Pasighat Highway Division, PWD, Pasighat has reported vide his letter no. PHD/ W-37/ 2015-16/916-17 dated 11th December, 2015 that M/s KNR Constructions Limited, Hyderabad has mobilized construction machineries, equipments, men and materials for the project and has geared up to achieve 60% progress of the Project of "2 laning of Gobuk - Marlyang- Sijhon Nallah Road from Km 26.210 (Gobuk) to Km 75.485 (Sijhon Nallah) (Existing Ch: Km 27.00 to Km 75.00) (Net Length:- 49.275 Km) (NH 513) (under SARDP-NE) in Arunachal Pradesh",

Whereas, the Executive Engineer, Pasighat Highway Division, PWD, Pasighat has recommended lifting of the debarment till 31st March, 2016 vide his above referred letter,

And, therefore, in view of the above and in interest of the works, the debarment order on M/s KNR Projects Limited, Hyderabad is hereby lifted till 31st March, 2016. The progress of the works as on March 2016 will be reviewed again in the first week of April, 2016 and a decision to re-inforce or waive the debarment notice will be taken therein.


