The competent authority in this Ministry has decided that while land for NH projects can continue to be acquired under the relevant provisions/sections of the National Highways Act, 1956. in consonance with the applicable provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (RFCTLARR) Act, 2013, wherever feasible, land for NH projects can also be procured in the State of Uttar Pradesh in accordance with the Government of Uttar Pradesh's order संख्या 2/2015/215/एक-13-2015-20(48)/2011 dated 19.03.2015 (copy enclosed).

3. This may be brought into the notice of all concerned authorities dealing with the acquisition of land in the state of Uttar Pradesh and it may be ensured that all determination of compensation for acquisition of land/bulk purchase of the land on consent basis is in consonance with the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (RFCTLARR) Act, 2013 and respective State Government's land laws/policies.
