
Please refer to your bid submitted on the subject matter mentioned above and previous communications in this regard.

2. This is in continuation of the previous communications in the subject cited matter. The evaluation committee noted that with respect to complaint regarding CV of the proposed Team Leader cum Sr. Bridge Engineer- Mr. Roberto Stefano during verification of the experience claimed by the Key personnel for the project titled "Construction of Kota Cable Stayed Bridge on Chambal River in Rajasthan India" for the period from 1.1.2009 to 17.12.2018" from National Highways Authority of India, it was observed that the TL worked on the project as the representative of M/s Socotec International, Singapore for the purpose of Safety Audit of the P5 Portion i.e. remaining portion after incident in 2009 and remained there for only 2 months. The same information received from PIU, NHAI was sent by Ministry to Mr Roberto Stefano on 30.06.2021 at his e-mail address [rstefano.sae.hk@gmail.com](mailto:rstefano.sae.hk@gmail.com) but no response has been received. Accordingly, it is noted that the **details uploaded on Infracon by the key personnel is inflated.**

3. In view of the above, as per Clause 3.4, (x) part a. of Section 2 of the RFPandas per the guidelines issued vide letter no. RW/NH-33044/24/2020-S&R (P&B) dated 06.01.2021, the **proposed Team Leader cum Sr. Bridge Engineer- Mr. Roberto Stefanois being debarred for a period of 2 years for future projects of Ministry and its executing agencies.**
