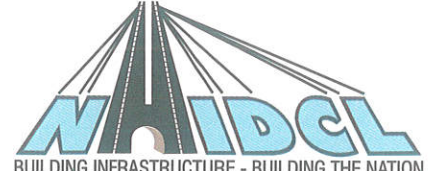

Ltd. in JV with Sowil Ltd for the work of Consultancy Services for supervision of "Improvement/Widening of 2 Lanning of stretch from Khongsang to Tamenglong (Design Length - 37.974ion) of NH-137 in the state of Manipur on EPC Mode under SARDP-NE.
