**Advertisement inviting applications from eligible persons for the post of Chairman and Members of National Road Safety Board (NRSB) by the Ministry of Road Transport and Highways, Government of India.**

2. The Ministry of Road Transport & Highways, Government of India hereby invites applications from interested eligible persons for the post of the Chairman and Members of National Road Safety Board.

3. The Office of the Board will be located in NCT of Delhi.

4. The National Road Safety Board (NRSB) has been notified by the Ministry of Road Transport & Highways, Government of India under the provisions of the Motor Vehicles (Amendment) Act, 2019. All matters of the Board and persons engaged for the Board will be governed by the MV Act, and the National Road Safety Board Rules, 2021.

5. **Number of vacancies:** MoRT&H proposes to fill up one post of Chairman, two Members and one Member (Admin & Finance). MoRT&H reserves the right to change the number of vacancies or cancel the selection process at any stage.

6. **Qualifications and age criteria:**

**6.1 Citizenship:** An applicant should be an Indian Citizen.

**6.2 Maximum age limit:** The maximum age limit for Chairman shall be 65 years and for Members shall be 62 years.

**6.3 Educational Qualification:** An applicant for the post of Chairman or Member of the Board should have Master's Degree in any stream from a recognized University.

**6.4 Experience:** An applicant for the post of Chairman or Member of the Board should be a person of ability, integrity and standing, having special knowledge of or professional experience in, one or more fields of administration, road safety, urban planning, law, traffic management and regulation, health and advocacy, police enforcement and investigation, transport engineering, insurance, automobile engineering, civil engineering and public transport.

**6.5 Minimum age and year of experience:** (i) Chairman, unless he has attained 55 years of age coupled with a minimum experience of 30 years in any of the fields mentioned in para 6.4;

(ii) A Member, unless he has attained 45 years of age coupled with a minimum experience of 20 years in any of the fields mentioned in para 6.4;



7. **Selection Process:** All the applications received in response to the advertisements will be scrutinised and short-listed. The Chairman of the Board or its Members shall be appointed by the Central Government on the recommendation of a Search-cum-Selection Committee.

8. **Tenure:** The period of engagement of a person for the post of the Chairman or Member under this advertisement shall not exceed three years. Termination during the tenure shall be governed by the NRSB Rules, 2021.

9. **Office:** The Chairman and other Members of the Board selected against this advertisement shall be whole-time Members and shall not hold any other office.

10. **ENTITLEMENTS :**

**10.1 Remuneration:** A person selected as Chairman or Member of the Board shall be eligible for a fixed remuneration and perks as detailed below :-

Note:(i) The Chairman or Member shall not be eligible for allotment of Government accommodation.

(ii) In case a serving employee of the Central Government or State Government is selected as Chairman or member of the Board, his/her services as Chairman or Member of the Board will be treated as Government services for all purposes.

**10.2 Allowances:** The Chairman/Members shall be entitled for TA/DA on official tour, medical reimbursement of expenses incurred at CGHS empanelled Hospitals/Diagnostic Centres at CGHS rates, newspaper allowances, Residential Telephone etc.

**10.3 Leave:** Chairman / Members of the board shall be eligible for 8 days' leave in a calendar year on pro-rata basis. He/she will not be entitled to draw any remuneration for any absence beyond 8 days in a year (calculated on a pro-rata basis). Also un-availed leave in a calendar year shall not be carried forward to next calendar year.

**10.4 Library Facility:** The Chairman/Members shall have access to the Ministry of Road Transport & Highways Library during the period of their engagement and shall be allowed to borrow books as per the Library Rules.
