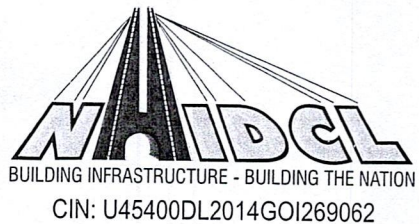

It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that **Mr. Pramod Dubbey** was appointed as the Sr. Bridge Engineer by M/s Yongma Engineering Co. Ltd. in association with Techniko Consultants Pvt. Ltd. for the work "Consultancy Services for Authority's Engineer and Engineer In- Charge as applicable for Km 0.00 To Km 330.70 of Andaman Trunk Road in the Union Territory of Andaman & Nicobar Islands for EPC Contracts Packages (Total Length= 177.85 Km) and Item Rates Contracts (Total Length= 64.40 Km) respectively".

2. **Mr. Pramod Dubbey** has provided his consent at the time of joining for his availability for the entire duration of the subject project, but he has not completed the assignment and absconded from the site, thereby violating CA, TOR, Section-6, Clause 11.2.

3. Therefore, as per stipulation of the CA, TOR, Section-6, Cl. 11.2, **Mr. Pramod Dubbey** is hereby debarred for 2 years from engagement on NHIDCL and projects of MoRTH to be undertaken by it either directly or indirectly through NHAI/PWD/other agencies effective from the date of this circular.
