OFFICE ORDER

Whereas, M/s R.K. Construction (India) Pvt. Ltd., Registered office at Sector-II, 2/677, Jankipuram, Lucknow State -Uttar Pradesh.-226024 has found indulged in fraudulent practice, by submitting fake and unauthentic bank guarantee against performance security for the work "Construction & widening of ROB existing (Railway portion & approach) at Km 76 of old NH-116 (New NH-552Ext.) in Sawai Madhopur City in the State of Rajasthan on EPC mode {Job No.-NH-116(New NH-552Ext.)-RJ/2020-21-760}", on the date 10th February, 2022. In addition to it the company also failed to submit required performance security for the work before the deadline mentioned in RFP of the work and not adhere with condition mentioned in bid securing declaration submitted by company itself as per appendix II of RFP.

Therefore as per conditions mentioned under clause 4.2 of RFP, M/s R.K. Construction (India) Pvt. Ltd., Registered office at Sector-II, 2/677, Jankipuram, Lucknow State -Uttar Pradesh.-226024 is hereby debarred from participating in any tenders or RFP issued by the authority i.e. Chief Engineer (NH & PPP) PWD Rajasthan, Jaipur during a period of 2 (two) years from the date 10th February, 2022. In addition to it as per conditions mentioned under bid securing declaration submitted with RFP of the work, the company is also suspended for participation in tendering process for the works of MoRTH/NHAI/NHIDCL/State PWD and works under other centrally sponsored schemes, for a period of One year from bid due date i.e. 16th August, 2021.
