### **OFFICE MEMORANDUM**

**Subject** : Constitution of the Committee for Examination of proposals involving minor deviations from the prescribed guidelines/norms for grant of permission of approach road access to Fuel Stations, Private Properties, Rest Area Complexes etc.

The Ministry of Road Transport and Highways grants permission for access to Fuel Stations, Private Properties, Rest Area Complexes etc. along NHs in accordance with the guidelines issued by the Ministry vide Circular No. RW/NH-33023/19/99-DO-III dated 24.07.2013.

2. However, the Ministry has been receiving a large number of requests from public representatives about permission for approaches to Retail Outlet involving minor relaxation from the norms. To have uniformity and also to ensure consideration and speedy disposal of cases involving deviations from the prescribed guidelines, the following Committee has been constituted with the approval of Hon'ble Minister, Road Transport & Highways:

(i).	DG(RD) & SS	-	Chairman
(ii).	CE(S, R & T)(Roads)	-	Member
(iii).	Director (IFD)	-	Member
(iv).	SE(S&R)R	-	Member Secretary

3. All cases involving minor deviations from the guidelines to be allowed in the public interest, shall be referred to this Committee by the concerned Chief Engineers of the Project Zones for consideration. Accordingly all the concerned Chief Engineers may please forward the summarized details of deviation cases of retail outlets, in the enclosed proforma, to Member Secretary of the Committee to put up the cases to Committee.

4. The concerned Chief Engineer of the Project Zone as well as Co-ordinator of that zone shall be invited for the meeting as special invitees for presenting the proposals of such deviation cases before the Committee.

5. It is accordingly informed that the First meeting of the Committee will be held on the **29<sup>th</sup> April 2015 at 11:00 hrs** in the Conference Room (Ground Floor) of Transport Bhawan to consider the cases received by the Member Secretary up to 24.04.2015. The concerned Chief Engineers as well as Co-ordinators may please attend the meeting to present the cases.
