Madam/Sir,

I am directed to convey the sanction of the President to allocate and release of fund amounting to Rs.642.27 Crore (Rupees six hundred forty two crore and twenty seven lakhs only) to National Highways Authority of India under NH(O) General-CRIF for the F. Y. 2025-26.

2. The above expenditure is debitabale to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2025-26:-

5054	Capital Outlay on Road & Bridges (Major Head)
01	National Highway (Sub - Major Head)
01.337	Road Works (Minor Head)
03	National Highways Original Works
03.01	National Highways Original Works - General - Funding from CRIF
03.01.73	Infrastructural Assets

3. There is total RE provision of ₹ 672.97 crore under NH(O)-General- CRIF for the financial year 2025-26. Out of which Rs.30.70 crore has been allocated to State of Bihar. After release of this amount of Rs 642.27 crore, the balance under the Head would be NIL.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.

6. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

7. This issues with the concurrence of Finance Wing's Note No.#273 dated 14.2.2026.

8. The Section Officer (W&A Section) will be Drawing & Disbursing Officer in connection with the amount sanctioned above. An amount of ₹ 642.27 Crore (Rupees six hundred forty-



two crore and twenty-seven lakhs only) may be credited in RBI E-Kuber CAN A/c No. 10698001008 of CS-NHAI - Works under Road Wing through electronic transfer.
