**Subject: Submission of original EMD/Bank Guarantee (BG)/tender fee for NH and other centrally sponsored road works.**


As per earlier directions from Ministry, all the States are following e-tendering for centrally sponsored road works. The bidders who are submitting bids electronically from different parts of the Country are facing certain problems in submission of original EMD/BG & tender fee. Ministry after considering representation from bidders and analyzing the process of electronic bid submission, has decided that

- i) All the State governments should allow the submission of Earnest Money Deposit (EMD) or Bid Security and cost of tender document, if any, in original form at followings offices of State/Central Government within seven days (7days) after the last date of submission of bids. This condition should be mentioned in NIT (Date and time to be specifically indicated in the NIT in each case).
  - Concerned Executive Engineer's office of State Government
  - Concerned Superintending Engineer's office of State Government.
  - Chief Engineer's Office of State Government.
  - Regional office of Ministry of Road Transport & Highways in the State.
  - The Chief Engineer of concerned zone at Ministry's Head Quarter.

- ii) Further, the software to upload, receive and access the uploaded tender should be designed in a way that no authority/ bidder could get the information, in whatever manner, on the details of bidders( i.e. details regarding numbers of bids loaded or names of bidder who have downloaded the bid documents etc) till the dead line for submission of hard copy of documents i.e. bid security and cost of tender.
