Kind attention is invited to the Ministry's O.M. No. NH-14019/15/2004-P&M, dated 8th November, 2004 vide which a Committee was constituted for examination of proposals involving minor divisions from the prescribed guidelines for grant of access permission to fuel stations, private properties, rest area complexes and such other facilities along National Highways (NHs).

2. In this regard, it is to intimate to that Ministry vide letter No. RW/NH-33023/19/99-DO-III, dated 24th July, 2013 has issued revised Guidelines / Norms for access permission to fuel stations, private properties, rest area complexes and such other facilities along NHs. These norms have been framed keeping in view the safety of traffic and pedestrian. Necessity for continuation of above Committee was examined in the above background and felt that cases confirming with the revised guidelines only be granted permission. Cases deviating from the prescribed guidelines shall be discouraged. Accordingly, the Committee mentioned at Para-1 ceases to exist from the date of issue of this circular.

3. It is requested that the contents of this letter may be brought to the notice of all concerned for needful compliance.
