In continuation to Ministry's Circular of even no. dated 24.07.2013 on the subject captioned above, the following Corrigendum is issued:

S. No.	Existing	Amendment
1.	At the end of Para 2 (Page 1) of the Circular dated 24.07.2013	<u>To be added:</u> However, in case of the proposals for access permissions to the National Highways, submitted to the Ministry/ NHAI offices prior to the date of issue of this Circular, the technical parameters shall be governed by the Ministry's earlier guidelines dated 25.09.2003/17.10.2003. The access permission in such cases shall be granted as per the provisions in Para 3 of this Circular.
2.	At the end of Para 11 (Page 3) of the Circular dated 24.07.2013	<u>To be added:</u> The Highway Administration may grant one-time extension up to one year for the period of construction, on genuine grounds and with proper justification(s) for the delay.
