
M/s Reliance Jio Infocomm Ltd. vide their letter no. RJIL/OFC/ROW/MoRTH/2015-16/30 dated 04.03.2016 has requested the Ministry for granting the permission for installing 6435 Ground Based Masts (GBMs) spanning across many states (**Annexure-I**).

2. In accordance with Para 7 of the Ministry's circular no. H-39011/16/2012-P&P dated 02-04-2014, a Committee was constituted to act as a Single Window for coordinating all activities for granting ROW permission to Telecom Services Licensees/Infrastructure Providers for installing telecom infrastructure along National Highways. A meeting of the Committee under the chairmanship of CE, SR&T (R) was held on 22.03.2016 wherein the aforesaid proposal of M/s Reliance Jio Infocomm Ltd. for installation of 6435 Ground Based Masts (GBMs) was discussed in the light of Ministry's extant guidelines. The aforementioned Committee recommended that the instant Proposal of installing of 6435 nos. of Ground Based Masts (GBMs) should be forwarded to the respective Highway Administration for technical feasibility vis a vis availability of space in the ROW, determination of license fee and its deposition with the Highway Administration and for making agreements in the matter as per the conditions stipulated in the Ministry's circular dated 02.04.2014. The Minutes of the Meeting of the Committee are enclosed as **Annexure-II**.

3. On the basis of the recommendation of the Committee, the Competent Authority has approved to grant single window clearance to the instant proposal of M/s Reliance Jio Infocomm Ltd. for installation of 6435 Ground Based Masts (GBMs) in the states as per list enclosed in **Annexure-I**, and forwarding the same to the respective Highway Administration for making requisite agreements in the matter as per the conditions laid down in the Ministry's said Circular dated 02.04.2014 after making Joint Survey with the representatives of the applicant regarding technical feasibility and for determination of license fee and its deposition with the respective Highway Administration. The respective Highway Administration is requested to take further necessary action in the matter accordingly.
