**Sub: Movement of Over-Weight and Over-Dimensional Consignments (OWCs/ODCs)**


Please refer to my letter of even number dated 30<sup>th</sup> September, 2013 regarding grant of permission for movement of Over-Weight and Over-Dimensional Consignments (OWCs/ODCs) as per letter No. RT-11042/13/2008-MVL dated 3<sup>rd</sup> September, 2008 and letter No. RT-11042/13/2008-MVL dated 22<sup>nd</sup> January, 2010.

2. In this regard this is to clarify that pending completion of survey of structures by this Ministry, the project Directors concerned may process references for permission ODCs/OWCs from the Nodal officers/Transport Commissioners on the basis of the Tables in paras 4&5 of our Ministry's letter No. RW-NH-35072-1-2010-S&R (B) dated 24.1.2013 read with letter No. RW-NH-35072-1-2010-S&R (B) dated 20.09.2013 except in cases where specific routes of damage to the structures are available with Project Administrator. The rates of and modalities for, payment of fee for movement of ODCs/OWCs shall be as laid down in para 3 of the aforesaid letter dated 20.09.2013.
