

OFFICE ORDER


With the approval of Competent Authority in the Ministry of Road Transport & Highways, it has been decided to engage Shri Saste Dattatraya Pandurang as Technical Consultant (Heavy Motor Vehicle (above 3.5 ton) in the Ministry of Road Transport & Highways with immediate effect for a period one year or until further orders whichever is earlier. Shri Saste Dattatraya Pandurang will be attached to Road Transport Wing as "Technical Consultant" for giving advice/inputs and other issues of MVL Section, on the following terms & Conditions:

- i) His engagement as "Technical Consultant (Heavy Motor Vehicle (above 3.5 ton) in the Ministry of Road Transport & Highways" will be on full time basis initially for a period of one year or until further orders whichever is earlier. The engagement will, however, be liable to be terminated at any time without assigning any reasons thereof.
- ii) Duties and Functions:
 - (a) Assist in issues related to testing and analysis of passenger cars, outdoor testing, planning & coordination with test agencies for vehicle homologation, audit, series monitoring, COP, Analysis or parts.
 - (b) Issues relating to Vehicle durability, field test coordination.
 - (c) Prepare Test documentation, write work instructions
 - (d) Ensure satisfactory progress, Investigate problems and determine root cause and necessary actions.
 - (e) Any other responsibilities assigned from time to time.
- iii) His engagement as "Technical Consultant, Heavy Motor Vehicle (above 3.5 ton)" on contract basis will further be governed by the instructions contained in the DOPT's O.M No. 16012/7/1997-Estt. (Allowance) dated 13.02.1998.
- iv) Remuneration:- Shri Saste Dattatraya Pandurang will be paid monthly consultancy fee of Rs. 1,00,000/- Per month plus Service Tax, if applicable and Rs. 5,000/- as local conveyance allowance.
- v) Allowances: - He will not be entitled to any allowance such as Dearness Allowance, Residential Telephone, Transport facility, Residential Accommodation, Personal Staff, CGHS, Medical Reimbursement etc. from Central Government pool or any relief etc. The Consultant would also be entitled to mobile telephone facility. The maximum reimbursable amount would be Rs. 1000/- per month.
- vi) Leave: - "Technical Consultant" shall be eligible for 8 days leave in a calendar year on pro-rata basis. He will not be entitled to draw any remuneration for any absence beyond 8 days in a year (calculated on a pro-rata basis). Also un-availed leave in a calendar year shall not be carried forward to next calendar year. The Ministry should be free to terminate the services in case of absence of a "Technical Consultant" by more than 15 days beyond the entitled leave in a calendar year.

- vii) TA/DA: No TA/DA shall be admissible for joining the assignment or on its completion. "Technical Consultant" will not be allowed foreign travel at Government expenses. However, "Technical Consultant" shall be allowed TA/DA for their travel inside the country in connection with the official work as per details specified below:
- c) TA- Reimbursement of Second AC Train Fare (including Rajdhani & Shatabdi)/Air fare (economy class).
 - d) DA- Reimbursement for Hotel accommodation of up to Rs. 1500/- per day; reimbursement of travel charges of up to Rs. 150/-per diem for travel within the city and reimbursement of food bills not exceeding Rs.200/- per day.
- viii) For above duties he will be reporting to Joint Secretary (T).
- ix) Library Facility:- The "Technical Consultant" shall have access to the M/o RT&H library during the period their engagement and shall be allowed to borrow books as per the Library Rules.
- x) He will not take up any other assignment during the period of Consultancy without the prior approval of the Ministry of Road Transport & Highways.


