OFFICE ORDER NO.73/2003

Subject: Transfer of Group 'A' Technical officers in the Ministry of Road Transport & Highways - Policy regarding.

The transfer policy of Group 'A' technical officers of the Ministry of Road Transport & Highways has been in practice as per Office Order No.49/81 (F.No.RW-A-22(35)/78) dated. 07.04.1981. Having regard to the development taken place and expansion of National Highways during the past 20 years and experience gained in the past, it has been found necessary to review the existing guidelines to make it more functionally oriented. The Competent Authority in the Ministry of Road Transport & Highways has, therefore, decided that henceforth, subject to exigency of public service and administrative reasons, the following guidelines will now be followed in making transfers of officers from the headquarters to the Regional Offices/Engineer Llaison Offices and vice-versa:-

(I) Transfer of all Group 'A' officers shall be approved by the Minister (RT&H).

(ii) There shall be a Committee (known as the Annual Transfer Committee) headed by Secretary (RT&H) with DG(RD)_& SS, AS & FA, JS(T) and Adviser (TR) as Members, for annual transfers of Group 'A' officers. The Committee shall recommend to the Minister the names of the officers to be transferred by end-January every year.

(iii) The normal tenure of an officer at a particular place will be as under:-

- (iv) Officers shall be given option to request for transfers by end-November every year.
- (v) After obtaining the approval, orders of transfer will be made before end-February every year.

2. This shall, however, not prevent any transfer made in public interest at any point of time during the year of transfers made due to unforeseen contingencies approved by the Minister (RT&H).
