The undersigned is directed to say that the Government has notified the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the limits for Exemption of Assets in Filing Return Rules 2014 under the Lokpal and Lokayuktas Act 2013 on 14<sup>th</sup> July 2014. The same is available on Department of Personnel and Training's website. Accordingly, every public servant is now required to file declaration, information or return, as the case may be regarding his assets and liabilities as on 31<sup>st</sup> March every year to the Competent Authority on or before the 31<sup>st</sup> July of that year. Every public servant is also required to file revised declarations, information or return as the case may be, annual returns as on the 1<sup>st</sup> August 2014 to the Competent Authority on or before 15<sup>th</sup> September 2014.

In view of the above, all the Group 'A' Technical Officers of Central Engineering Service (Roads) and Group 'B', 'C' & 'D' Non-Technical Officials (posted at Regional Offices of the Ministry) of General Central Service are requested to file their revised declarations, information and returns to E.II Section well before the closing date of 15.09.2014.
