2. The sanction of the President is also conveyed towards creation of 86 posts of Assistant Executive Engineers as Special Deputation Reserve to be utilised for the purpose of deputation outside the cadre strength in addition to the normal vacancies arising in the JTS level i.e. Assistant Executive Engineer in the cadre subject to the condition that the total Cadre Strength for the purpose of promotion at any point of time shall not exceed 242. However, recruitment can be made against a total of 328 posts(242+86).
