#### Invitation of Public Comments

Subject: Issue of NOC for construction access road to new MS/HSD retail outlet abutting on RHS boundary of NH - 206 (Tumkur – Honnavar Section) at Km 25.570 in Sy. No. 101/1 of Herur village, Gubbi Taluk, Tumkur District, Karnataka State – Reg.

The proposal seeking access permission to the above retail outlet of M/s. MRPL was submitted by The Executive Engineer, NH Division, Tumkur, vide letter No. EE/NHD/Tmk/AE-1/NOC/2017-18/1498 dated 07.11.2017 and 21.12.2017 (Annexure – I) seeking NOC under relaxation due to the existence of cross road intersection at a distance of 153.3m as against minimum of 300m. Oil company vide letter No. MRE/PB/910 dated 18.12.2017 (Annexure – II) has also requested to consider the proposal under relaxation. Further, DGM (T) & Project Director, NHAI, PIU, Chitradurga vide letter No. NHAI/PIU-SMG/12022/01/2017-18/84 dated 19.07.2017 (Annexure – III) has stated that NHAI has taken up DPR for 4-lanig of Tumkur-Shimoga section of NH-206 and as part of 4-laning, new bypass has been proposed for Gubbi town, which starts from Km 18.240 and ends at Km 26.900.

2. Since the Intersection with the rural road/approach roads are at distances of 153.3m, 257m, 279.3m on LHS and 192m, 239.3 & 299.7m on RHS from the proposed retail outlet site as against minimum of 300m, the proposal necessitates relaxation.

3. As per the guidelines issued by the Ministry vide OM No.RW/NH-33023/19/99-DO-III dated 16.03.2016 (Annexure – III), the relaxation application will be made available for public comments and the comments will be invited within 60 days from the day of uploading. The comments needs to be submitted in the Format enclosed as Form- A.

Dear Sir,

Referring your above cited letter, regarding observations made on the proposal for getting NOC to establish new R.O. Our pointwise compliances on the above stated observations are as under,

SR.No	OBSERVATIONS	COMPLIANCES
	Oil company M/s MRPL, vide letter cited at reference (i) above, nas sought relaxation w.r.t the intersection of rural roads at 153.3m, 190.0m and 252.8m atating that these roads lead to residence colony. However, Proper justification for relaxation needs to be given for considering the proposal under relaxation.	There are minor intersections connecting to residential properties imminent with in the distance of stipulated guidelines of Ministry. As we have noticed there are very negligible numbers of vehicle travels through this cross roads such as one or two vehicles per day. By reckconing the traffic movement through this cross roads there will not be any chance for vehicle congestions at the junctions of the intersections. Also we bring to your kind notice that, there is NHDP-IV Phase development of NH-206 by bypassing the stretch of KM 18.240 to26.900. MRPL proposal for setting up of fuel station is in KM.25.570. Hence, the maximum number of vehicle will move through the future 4 lane highway. Also there will not be any hindarance for construction of accelaration and decelaration lane for the proposed R.O. In addition, we declare from our end that maximum attention will be given for smooth travel of vehicle through this stretch and also for road safety. So we are requesting to consider the proposal under relaxation.

2.	Also, the intersection with number of rural roads along with the distances marked in the layout plan does not match with in the videography submitted with the proposal. This needs to be reconciled.	The discrepancy observed in the videography in comparison with the key plan has been corrected. Accordingly, a fresh videography incorporating this minor correction in line with the measurement of the revised key plan is enclosed for your kind perusal. Also one overlooked intersecting road connecting to residential property at a distance of 279.3 meters from the edge of R.O site has been incorporated in the revised 1.5 KM topographical plan.
3.	It is observed that the document enclosed with the proposal such as License agreement, Checklist etc., is without the seal of the Authorized signatory. This needs to be reconciled.	As you have advised, the documents such as License agreement, Checklist have been endorsed with authorised seal and signature.

Now we, request your kind office to approve our proposal by considering our compliances given as above.

### Sub: Guidelines/norms for access permission to Fuel Stations, Private Properties, Rest Area Complexes and such other facilities along National Highways- reg.

The power to give for access to National Highways lies with the Highway Administration as per the Highway Administration Rule. 2004 under the control of National Highways (Land and Traffic) Act. 2002. While exercising this power, the Ministry issued the general guidelines/norms for access permission to fuel stations. private properties. rest area complexes and other facilities vide Ministry's Circular No. RW/NH-33023/19/99-DO-III dated 24.7.2013. The norms and guidelines were issued as per enclosures of the Circular at Appendix-1 (along with Annex-I, II & III to Appendix-1) and Appendix-II (along with Annex-I, II and III to Appendix-II).

2. The Ministry has been receiving many cases of relaxation from the Ministry's norms stipulated in the Circular under reference. It has been observed that many cases of deviations from the extant guidelines, specifically distance from intersection, gap in central median, distance from nearest fuel station, distance from toll plaza and non-fulfillment of the criteria of construction within a year of issuing NOC have been received for relaxation by the Ministry. Further, many complaints and RTI applications against relaxation have also been received in the Ministry.

3. In view of the above, it has been decided that the application for relaxation in the guidelines/norms for access permission to fuel stations, private properties, rest area complexes and other such facilities along National Highway will be filled up by the applicants through online forms and will be submitted to the concerned Highway Administrator. Before the issue of provisional NOC and in principle approval, the Highway Administrator will make available in the Ministry's website (morth.nic.in) the complete application for public comments, thereby bringing out the relaxation sought by the applicant. Comments will be invited within 60 days

from day of uploading and will be in the format as enclosed as Form-A. The Highway Administrator will subsequently take the decision on the application in a speaking order for accepting or rejecting the relaxation sought and taking into consideration the objections received on the matter. The applicant may have a further period of 30 days for appealing against the Highway Administrator to the Appellate Authority who will be the Chief Engineer of the respective Project Zone in Ministry of Road Transport & Highways. Chief Engineers will take into consideration the application of the applicant seeking relaxation, the objections received from the general public and the speaking order of Highway Administrator to decide on the appeal. The order of the Appellate Authority shall be final.

4. The Highway Administrator will issue the 'in principle' approval and the Provisional NOC for the applications, where relaxation of norms has been sought, only after the completion of the process illustrated in the preceding paragraph.

5. This circular will be read in continuation with circular of Ministry dated24.7.2013 mentioned in first paragraph. The other provisions of the earlier circular will remain applicable.

6. The competent authority in the Ministry shall notify the Appellate Authorities for their respective Highways Administration. The contents of this Circular may be brought to the notice of all the concerned in your organization.

7. This issues with the approval of the competent authority.
