With reference to the above, it is informed that vide letter u/r(i) M/s GAIL(India) limited a Govt. of India undertaking has submitted a proposal for permission for laying GAIL'524" dia Natural Gas pipe line along with 40mm dia OFC duct/cable as an integral part of gas pipe line across the National Highway-31 at NH-design Km. 210+104 in village Mosadpur, Block, Barauni in dist: Begusarai.

2. The aforesaid proposal was forwarded to Authority Engineer of the subject project. vide letter u/r(ii) for site inspection and their comments.

3. Authority Engineer, vide letter u/r (iii) has submitted the following."The pipe laying site has been examined as per check list enclosed by GAIL, in presence of Mr. Uday Pratap Singh, Team Leader (Survey)GAIL, Mr. Virendra Singh Chauhan RCM M/s Punj Lloyd Ltd. and our Resident Engineer Mr. Nirpendra Kumar at Desing Km 218+104 of NH-31 in village Mosadpur, Block-Barauni in distt. Begusarai which is safe and without any obstruction. Construction will be done by Horizontal Directional Drilling(HDD) Methodology without disturbing the road surfaces. The depth of the pipe line at the mid span of the road will be at 7.00 M.


The Authority Engineer has further stated that permission for laying the gas pipe line can be granted with these conditions, that the methodology submitted should be followed strictly and quality assurance will be maintained by systematic implementation of this procedure and generating necessary quality records. If any charges will be applicable; the GAIL India will be solely responsible to pay them".

It has also been mentioned by Authority Engineer that prior to starting the work, it is essential to give information to the concerned authorities of NH-31 and the work should be done only in the presence of the E/I of NH-31.
