Subject: Permission Proposal for laying underground Optical fiber cable along the NH from Km 128/100 - Km 130/200 & Km 130/950 to Km 131/200 (LHS) (Tirumangalam - Kollam section) of NH 744 (old NH No.208) in the State of Tamil Nadu - Regarding.

The proposal is regarding permission for laying of Optical fiber cable M/s Bharti Airtel Limited, Chennai, Optical fiber cable along the NH from Km 128/100 - Km 130/200 & Km 130/950 to Km 131/200 (LHS) (Tirumangalam - Kollam section) of NH 744 (old NH No.208) in the State of Tamil Nadu was submitted to this office by the SE NH, Tirunelveli vide letter No.2784/2018/JDO dated 08.11.2018 (received on 14.11.2018) has submitted the proposal to this office in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by M/s Bharti Airtel Limited, Chennai, Optical fiber cable along the NH from Km 128/100 - Km 130/200 (LHS) & Km 130/950 to Km 131/200 (Tirumangalam - Kollam section) of NH 744 (old NH No.208) i.e. in a length of 2350m as detailed under:

- 3. The right of way is Varies 18 to 25.40 in the aforesaid stretch. The carriageway width of aforesaid stretch is 10m. M/s Bharti Airtel Limited, Chennai has proposed to lay the Optical fiber cable at the edge of the ROW for a length of 2350m. The entire length of 2350m the Optical fiber cable is proposed to be laid at a distance less than 15m which is not in conformity with Ministry's guidelines vide letter No.NHIII/P/66/76 dated 19.11.1976. Further, M/s Bharti Airtel Limited, Chennai has mentioned that the OFC is proposed to lay by using Trenchless method for distance is greater than 15m from the center line of the carriageway at a depth of 1.65m from the bottom of the

M/s Bharti Airtel Limited, Chennai., Chennai has furnished an undertaking to the effect that M M/s Bharti Airtel Limited, Chennai will remove the laid OFC line in future if required by NH wing of State Highways Department/MoRTH Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH land. Further, mentioned that M/s Bharti Airtel Limited, Chennai., Chennai will also restore the surfaces to its original condition soon after removal of the OFC lines. Also, certified that the proposed Optical fiber cable work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
- 5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the relaxation application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
