The Project Director, PIU, Hospet vide letter cited (8), has submitted the proposal of The Executive Engineer, Rural Water supply & Sanitation Department, Koppal Division, for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the laying of water supply pipeline along NH road from Ch.363+900 to Ch.364+130 (230m) on RHS and Ch.363+900 to Ch.363+960 (60m) on LHS side and 6 no.of road crossings at Ch.331+050, Ch.344+350, Ch.349+080, Ch.363+900, Ch.365+550 and Ch. 373+250 of NH-50 in the State of Karnataka.
- 3. As per para-4 of Ministry's Circular No. RW/NH-33044/29/2015/S & R (R) dated 22.11.2016, the Highway Administration shall be put out in the Public Domain for 30 days for Seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
- 4. In view of the above, the comments/objections of affected public is hereby invited with reference to Ministry's circular dated 22.11.2016 for the above mentioned proposal. The objections/comments may be addressed to the below mentioned address, which should reach by this office within 30days from the date of publication beyond which no comments shall be entertained.
