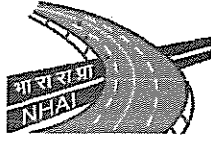

INVITATION OF PUBLIC COMMENTS

Sub.:- Construction of Six Lane access controlled highway (NH-152D) starting from Junction with Rewari-Kanina road (SH-24) near Kanina to Narnaul [Ch. 200 + 000 to 227 + 020 ; length 27.02 km] on EPC mode under Bharatmala Pariyojana in the State of Haryana (Pkg-8) - Crossing of Khetri-Bhiwadi 400 KV D/C Transmission line (Twin HTLS) associated with transmission scheme for evacuation of Power from Solar Energy Zones in Rajasthan (8.1) GW under phase-II, Part-F, through Tariff Based Competitive Bidding (TBCB) route - reg.

By way of this public notice, it is to inform all concern that M/s Powergrid Corporation of India Limited, Bikaner has submitted a proposal for Permission for Crossing of Khetri-Bhiwadi 400 KV D/C Transmission line (Twin HTLS) associated with transmission scheme for evacuation of Power from Solar Energy Zones in Rajasthan (8.1) GW under phase-II, Part-F, through Tariff Based Competitive Bidding (TBCB) route. The said pipe line has its crossing with NH-152D which is being implemented through PIU-Bhiwani under NHAI RO-Delhi, at Km. 221.210 in PKG-8.

2. As per Para-4 of Ministry's circular no. RW/NH-33044/29/2015S&R(R) dated 22.11.2016, Highway Administration shall put out the same in the public domain for 30 days for seeking claims objections (on grounds of public inconvenience, safety, and general public interest). The approval for publication of this notice is accorded by NHAI RO-Delhi vide eoffice comp. no 182343


