Invitation of Public Comments

Sub: Proposal for access permission for approach roads at km 33/595 to 33/630 (RHS) on NH-59 to the proposed Retail Outlet of Shri Kalyan Dev Sah (Applicant of HPCL) at Mouza-Haldi, Tahasil-Muribahal, Dist-Balangir in the state of Odisha-reg.

- 1. Shri Kalyan Dev Sah (applicant of HPCL), i.e., the applicant, vide letter dated 09.12.2019 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 with respect to two nos of "intersection with Rural roads/approach roads to private and public properties" is at a distance of 126 m & 136 m respectively as against the norm of minimum distance of 300 m.
- 2. As per Ministry's OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal along with Form-A on the Ministry's website (morth.nic.in) to invite public comments, for a period of 60 days.
- 3. In view of the above, comments of public, if any, on the above relaxation proposal are invited online as well as in hard copy by enclosing location plan, justification & Form-A. The same should reach to the below mentioned address within 60 days from the date of uploading it, in the website, beyond which no objection will be considered.
