It is to inform all concern that EE PHED Project Div. Phalodi vide letter cited under ref. (i) above has submitted a proposal for the subjected work and PD, NHAI, PIU, Bikaner has submitted the above proposal vide letter under reference (ii) for approval of the Competent Authority, Highway Administration.

The proposal is for grant of permission to work done execution of works related to 'Coverage of 56 villages by providing function household top connection (FHTC) by retrofitting of RWSS Ghatore-Kansar-Bap Water supply project under Jal Jeevan Mission (JJM) of block Bap of Distt. 
