Sub: NHAI-PIU, Karaikudi- Laying of TWAD Water pipeline along the road from Km.129/000 to Km.130/200 (RHS), Km.130/200 to Km.131/400 (LHS) by Open Trench method & across the road in 4 locations at Km.129/160, Km.130/200, Km.130/750 & Km.131/300 by Trenchless Method on Karaikudi - Ramanathapuram section of NH 210 (New NH 536)- **Invitation of Public Comments - Reg.**

The proposal received from PD, Madurai vide letter No. PD, Karaikudi LrNo. NHAI/PIU/Karaiudi/11024/TWAD/2023/156 dated. 10.02.2023. there by requesting permission for laying along the road from Km.129/000 to Km.130/200 (RHS), Km.130/200 to Km.131/400 (LHS) by Open Trench method & across the road in 4 locations at Km.129/160, Km.130/200, Km.130/750 & Km.131/300 by Trenchless Method on Karaikudi - Ramanathapuram section of NH 210 (New NH 536) in the State of TamilNadu proposed by, Executive Engineer, TWAD Board, Project Division, Karaikudi. in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the, Executive Engineer, TWAD Board, Urban Division, Karaikudi. requesting permission for laying along the road from Km.129/000 to Km.130/200 (RHS), Km.130/200 to Km.131/400 (LHS) by Open Trench method & across the road in 4 locations at Km.129/160, Km.130/200, Km.130/750 & Km.131/300 by Trenchless Method on Karaikudi - Ramanathapuram section of NH 210 (New NH 536) in the State of TamilNadu detailed under;

4) Executive Engineer, TWAD Board, Project Division, Karaikudi, has furnished an undertaking to the effect that the applicant will remove the laid Water supply pipeline in future if required by NHAI/MoRTH, Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation. Further, mentioned that Executive Engineer, TWAD Board, Project Division, Karaikudi will also restore the surfaces to its original condition soon after removal of the Water supply pipelines.

5) Accordingly, as per Policy Guidelines issued by Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016., the application is being uploaded on public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
