Megha City Gas Distribution Private Limited, Trichy-Approval requested-Reg


- 1) The subject proposal is requesting a permission to laying of APL 5L GR x 52, 10" x 6.4mm thickness of CS underground Gas pipeline along the road from 41/942 to km 65/279 (LHS) of Tindivanam to Krishnagiri section of NH-66 in Tamil Nadu State
- 2) M/s. Megha City Gas Distribution Private Limited had given an undertaking to shift the utility line for any work of improvement or repairs to the road, If NHAI considers it as necessary, in the future, it will be carried out as desired by the NHAI at the cost of the applicant within a reasonable time (not exceeding 90 days) of the intimation given.
