The proposal received from PD, PIU-Madurai vide letter NHAI/PIU/MDU/NH-7/Utility/612 dated 03.03.2023. thereby requesting Permission for Erection of 110KV Tower line Crossing at Km.89+250 in Madurai - Kanyakumari Section of NH-44(Old No:NH-7) in the State of Tamil Nadu proposed by Superintending Engineer ,TANTRANSCO, GCC Madurai.

2) The alignment proposed by Superintending Engineer ,TANTRANSCO , GCC Madurai requesting Permission for Erection of 110KV Tower line Crossing at Km.89+250 in Madurai - Kanyakumari Section of NH-44(Old No:NH-7) in the State of Tamil Nadu as detailed under;

3) As mentioned in the PD letter, the ROW is 60 m at Km 89+250. As observed from the drawing, the Overhead tower are to be erected across NH at Km 89+250

4) In this instant proposal, the as certified by PD, Madurai Vertical Clearance for the proposed erection overhead electrical 110KV overhead Transmission line is 10.98 m.
