NHAI-RO Kerala-Six-laning of Start of Valanchery Bypass to Kappirikkad from Km. 298.500 to Km 335.850 section of NH-66 (Old NH-17) on Hybrid Annuity Mode under Bharatmala Pariyojna in the State of Kerala- Laying of Water Supply pipelines from Km.329+000-Km.333+019 RHS (90mm, 110mm, 140mm PVC Pipe, 200mm, 250mm, 400mm, 160mm DI Pipe) and Km.328+500-Km.333+112 LHS (90mm PVC) and across NH-66 at Km.331+054 (450mm DI Pipe) by Kerala Water Authority-Reg.
9. NHAI-RO Kerala-Six-laning of Start of Valanchery Bypass to Kappirikkad from Km. 298.500 to Km 335.850 section of NH-66 (Old NH-17) on Hybrid Annuity Mode under Bharatmala Pariyojna in the State of Kerala- Laying of Water Supply pipelines from Km.333+000-Km.335+561 LHS (90mm PVC Pipe) and Km.333+000-Km.335+561 RHS (90mm, 110mm, 140mm, 160mm PVC Pipe and 200mm DI Pipe)) and across NH-66 at Km.334+384 (250mm DI Pipe) by Kerala Water Authority -Reg.
10. NHAI-RO Kerala-4 Laning of Mukkola Junction to Kerala/Tamilnadu border) (from Km 26.500 - Km. 43.000) Section of NH-47 (New NH-66) under NHDP Phase-III in the state of Kerala on EPC Mode- Laying of Water Supply pipelines from Km.36+350-Km.36+470 RHS (90mm PVC Pipe) and across NH-66 at Km.28+100 & Km.28+540 (400mm and 250mm MS Pipe) and Km.39+060 (900mm, 700mm and 250mm MS Pipe) by Kerala Water Authority - Reg.

The proposal is regarding permission sought by Kerala Water Authority for laying of underground water supply pipelines as part of 'Jal Jeevan Mission' along/across the National Highways stretches in the subject project locations under NHAI in the State of Kerala.

2. The Managing Director, Kerala Water Authority (KWA) has furnished undertaking that:-

- a) They will ensure not to damage any other utilities during the process of laying and incase, if damaged, they will pay the losses either to NHAI or to the concerned agency.
- b) They will shift/relocate the underground Water supply pipelines when required by NHAI at the cost of Kerala Water Authority, notwithstanding the permission granted within such times as will be stipulated by NHAI for future widening/six laning of National Highway, or any other developments.
- c) They will obtain prior approval of NHAI before undertaking any work of installation, shifting or repairs, alterations to the underground Water supply pipeline located in the National Highway. Further, they will also bear all expenditure, if any, incurred by NHAI for repairing any damage caused to the National Highway due to laying maintenance or shifting the underground Water supply pipeline.
- d) If the NHAI considers it necessary in future to move the utility line for any work of improvement or repairs of the road, it will be carried out as desired by the NHAI at the cost of Kerala Water Authority within a reasonable time (not exceeding 60 days) of the intimation given.
- e) Further, KWA has undertaken for payment of the required license fee for utilization of NHAI land as and when demanded by the Highway Authorities and to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
- f) Kerala Water Authority has also undertaken to manage traffic movement during the execution of the work.

3. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposals submitted by Kerala Water Authority will be made available for 30 days seeking Public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
