Sub: NHAI - PIU, TRICHY - Trichy - Dindigul section of NH 83 - M/s Indian Oil Corporation Ltd, requesting permission for proposed erection of 11KV overhead transmission line from IOCL bottling plant to Inamkulathur to Ammapettai 110/11 KV substation at NH 83 from Km 345/364 to Km 342/300 (RHS) and crossing at Km 345/364 - Public Comments Invited - Reg.

The proposal received from PD, PIU-Trichy vide letter NHAI/PD/TRY/Utility/TNEB/NH-83/T-D/2023/486 dated 07.03.2023. thereby requesting Permission for Erection of 11KV overhead transmission line along from Km 345/364 to Km 342/300 (RHS) and crossing at Km 345/364 in Trichy - Dindigul Section of NH-83 in the State of Tamil Nadu proposed by Deputy General Manager, Plant Indane Bottling Plant, Indian Oil Corporation, Trichy.

2) The alignment proposed by Deputy General Manager, Plant Indane Bottling Plant, Indian Oil Corporation, Trichy requesting Permission for Erection of 11KV overhead transmission line along from Km 345/364 to Km 342/300(RHS) and crossing at Km 345/364 in Trichy - Dindigul Section of NH-83 in the State of Tamil Nadu as detailed under;

3) As mentioned in the PD letter, the ROW is 60 m along from Km 345/364 to Km 342/300(RHS) and crossing at Km 345/364 in Trichy - Dindigul Section of NH-83.

4) In this instant proposal, the as certified by PD, Trichy Vertical Clearance for the proposed erection overhead electrical 11KV overhead Transmission line is 14.25 m.

5) Deputy General Manager, Plant Indane Bottling Plant, Indian Oil Corporation, Trichy has furnished necessary undertaking to the effect that they will relocate the Over Head Transmission line and when requested by the NHAI at their own cost. It is also mentioned that, the proposed erection work of 11KV Over Head Transmission line along and across NH will not cause damage to any other utility, if damaged they will pay the losses either to NHAI or to the concerned agency as per Ministry Guidelines dated 22.11.2016.

6) Accordingly, As per the MoRTH guidelines vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016. The application is being uploaded on public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
