Sub: Proposal for grant of access permission to a new retail outlet of M/s BPCL at Km 277.651 to Km 277.776 (Khasra No. 1624) on NH-52 at Village-Mandana, Tehsil- Ladpura & District-Kota in the State of Rajasthan.

M/s HPCL Ltd ie. the applicant vide letter No.KRT/OSTS/Mandana-02 dated 04.02.2019 has submitted a proposal requesting this office to grant relaxation with regards to MoRTH Guidelines clause no.4.6.3 & 4.6.4 for clustering of retail outlet and regarding median opening falling within 300m. The proposal was forwarded to EE PWD NH Div-Kota vide this office letter 27.11.2018 for comments and factual report. EE PWD NH Div-Kota vide letter No.1057 dated 29.01.2019 received in this office dated 31.01.2019 has submitted the required report. There exists a intersection with rural road at 224m against 300m as per MoRTH guidelines. Also Gap in the central median from fuel station (for divided carriageway) is at 224m against 300m as per MoRTH specification and distance between two fuel station is at 946 against 1000m as per standard MoRTH guidelines. However the proposed retail outlet proposal is submitted in this office with a provision to construct service of 5.50m wide and 310m long as per the proposed drawing which will be constructed and maintained by oil company at their own cost and undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

- 2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.
