Sub: -Four Laning of Rewa-Katni-Jabalpur Section of NH-7 from km. 418+733 to km 446+000 in the State of Madhya Pradesh under NHDP Phase-IV on EPC mode – Regarding permission for pipe lying along National Highway from Panagar to Sihora.

Please refer to your letter under ref. (2) cited above forwarding therewith the Application submitted by Project Manager, Madhya Pradesh urban development company limited (MPUDCL), PIU, Jabalpur (Applicant) seeking permission for laying of Water pipelines within available ROW of NH land from Panagar to Sihora section from Km. 418+733 to 446+000 on NH-7 in the State of Madhya Pradesh under provisions of Guidelines for accommodation for Public and Industrial Utility Services on NH vide Ministry's circular no. RW/NH-33044/29/2015/ S&R (R) Dated 22.11.2016.

2. The application along with recommendation of RO/PD, NHAI has been examined and proposal has been found to be in order. Accordingly, the permission for laying of water pipe line in a length of 24.087 Km from Km. 418+733 to 446+000 (**Rewa-Katni-Jabalpur Section**) on NH-7 is granted to the Applicant (to be referred as Licensee upon signing of License Deed) as per Ministry's circular dt. 22.11.2016 and following conditions:

Cond/-

- 2.1 Proposal for laying of pipeline is being uploading in the Ministry's website for invitation of public comments and the approval is subject to comments from public. In case of any adverse comments from public, approval would then be cancelled.
- 2.2 That the work shall be executed as per the norms & conditions prescribed under the license agreement to be signed by the applicant with PD, PIU, Jabalpur.
- 2.3 Necessary fee for five years for the use NH land as per Ministry's Policy Circular shall be got deposited to Central Government A/c by Project Manager, MPUDCL, PIU, Jabalpur before giving permission to the company. (Ref para 5 of circular).
- 2.4 BG for the specified amount as per the circular for restoration, maintenance work subsequent to laying of Water Pipeline shall be obtained by NHAI from the company with validity of one year which may be extended as per requirement till satisfactory completion of work by the Licensee. (Ref. para 6 of circular).
- 2.5 Planning and execution of civil works for laying of utility including restoration works shall be carried out by the Licensee as per conditions of License Agreement and applicable MoRT&H & IRC norms so that the Civil works required for laying of proposed Water pipeline should meet the specifications and guidelines issued by IRC, as well as MoRT&H.
- 2.6 Licensee shall ensure that existing drainage structures shall not be used or disturbed for laying of utility and the top of casing/conduit Water Pipelines shall be at least 1.20 m below the top of sub grade or the existing ground level, whichever is lower, subject to being at least 0.3m below the drain inverts. A typical sketch showing the clearances is given in Attachment-I to the Ministry's guidelines.
- 2.7 The complete cost of water pipeline laying and cost of shifting of existing utility (if any required) has to be borne by the agency.
- 2.8 Prior approval of the Highway Authority shall be obtained before undertaking any work of installation, shifting or repairs, or alterations, to the Water Pipeline located in the ROW.
- 2.9 Expenditure, if any, incurred by the Highway Authority for carrying out repair of any damage caused to the National Highway and all associated project facilities by the laying, maintenance or shifting of Water Pipeline will be borne by the Licensee (agency owning the line).
- 2.10 If the Highway Authority (NHAI/MPRDC/ State PWD/Ministry) considers it necessary in future to shift the Water Pipeline for any work of improvement/ upgradation or repairs to the existing Highway or for addition of any project facility such as service road, bus bay, foot over bridge etc., the same will be carried out, as desired by the Highway Authority, at the cost of the Licensee /agency owning the utility line within a reasonable time (not exceeding 60 days) of the intimation given. Also the road land shall be restored to its original

cond/-

condition by the agency, as and when required to do so by the Highway Administration or any person authorized on its behalf and the Licensee (concerned utility owning agency) shall not be entitled to any compensation on account of such removal or restoration work.

- 2.11 The Highway Authority shall ensure that the road shall be at all time kept in traffic worthy condition during construction/ laying period and the traffic should continuously move safely and without hindrance during laying of Water pipeline.
- 2.12 This permission given to Licensee would be valid for a maximum period of 5 years from the date of permission at a time, which can thereafter be considered for renewal upon payment of additional fee at the time of renewal, for which rate prevailing at the time of renewal shall be charged. Delay in deposition of renewal fee shall attract interest @ 15% per annum compounded annually.
- 2.13 In case the Licensee fails to discharge the obligation of making good of the excavated trench/other restoration work, the Authority shall have a right to repair/make good the damages caused by excavation at the cost of the Licensee and recover the amount by forfeiting of the Bank Guarantee. In case, the Performance Bank Guarantee is invoked as mentioned above, the Licensee shall be required to replenish and reinstate the required Performance Bank Guarantee within one month of such invoking.

3. It is noted that the license fee of Rs. 9,37,090/- has been deposited by the applicant in the account of NHAI and whereas, as per the procedure the said fee is to be deposited in the account of Highway Administration (RPAO, MoRT&H, Raipur) and therefore, this license fee needs to be deposited in the account of Highway Administration (MoRT&H, Bhopal). Accordingly, it is requested to remit the aforesaid license fee in the following designated account of MoRT&H, Bhopal.

Since, the applicant has already deposited the fee in account of NHAI and therefore for the purpose of permission, PD, Jabalpur shall ensure that the license fee is submitted to MoRTH.


4. Accordingly, it is requested to intimate to the Applicant the permission for laying of water pipeline hereby granted by the Competent Authority subject to conditions mentioned in Para 2 above. However, before intimating the same to Applicant following may be ensured:

contd/-

- i. The applicant shall enter into a License Agreement with the Authority (PD, NHAI, Jabalpur) as per format enclosed in **Appendix** to the policy circular dated 22.11.2016, including any other conditions imposed by the Authority (PD) at the site for ensuring safe and uninterrupted flow of traffic during execution. Highway Administration, under the provisions of Para -21 of Control of (Land & Traffic) Act, 2002 delegates the Authority to sign license agreement on behalf of Highway Administration to PD, PIU, NHAI, Jabalpur for this purpose.
- ii. BG submitted by applicant shall be verified from the issuing Bank and validity of the same shall be ensured as per provisions of guidelines.

5. This issues with the approval of Competent Authority.
