Superintending Engineer, NH Circle, Jind vide his memo No. 17236 dated 25.01.2019 (**copy enclosed**) has re-submitted the NOC case for the subject. In this context, it is submitted that there is a median gap and village road (Kacha rasta) at a distance of 73m from proposed fuel station. RO, Chandigarh vide letter under reference had desired to close the median gap which is not possible as there is a kacha path for movement of tractor, trollies and buggies by the local farmers of village Baniyani. Moreover, there is a law and order problem in closing this median cut. There is a mandir at a distance of 65m. So the acceleration lane be provided 60m + 30m = 90m instead of 100m. Hence relaxation is required in two cases.

- 1. Median gap and village road (Kacha rasta) at a distance of 73m from proposed fuel station be allowed.
- 2. There is a mandir at a distance of 65m. So the accrelation lane be provided 60m + 30m instead of 100m.

The case submitted by SE NH Circle Jind is recommended for according necessary approval/permission of NOC from the competent authority after considering relaxation to M/s HPCL in norms of MORT&H regarding above mentioned points.
