Sub: Sub: Proposal for grant of access permission to retail outlet of M/s HPCL in the km 53/39.5 to 53/89.99 RHS on NH-54 (Khasra no. 12 & 19) at Village - Chak 19JRK, Tehsil - Hanumangarh, District - Hanumangarh in the State of Rajasthan.

M/s HPCL Ltd ie. the applicant vide letter dated NIL received to this office on 30.01.2019 has submitted a proposal to this office on above mentioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/NH-33023/19/99-DO.III dated 24.07.2013 as there exist an intersection with a rural road, at a distance of 61m from proposed retail outlet, as against stipulated norm of minimum 300m, thus violating the Ministry Guidelines. However the applicant has submitted proposal in this office through service road of 5.50m wide and 296.49m (including AL,DL) long service road extending upto above mentioned rural road (at a distance of 61m) to be constructed and maintained by the applicant at his own cost, to take due care of (Earthen track upto agriculture fields) safety and smooth traffic on road and undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRT&H and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.
