Invitation of public comments

Sub: Proposal for grant of access permission to a new retail outlet of M/s Nayara Energy Ltd (Formerly known as M/s Essar Oil Ltd) at km 119/055.50 to 119/090.50 (LHS, Khasra No.224/2, revised Khasra No.224/3 as per conversion) on NH-12 at Village-Ahmedpura Chowki Chhan, Taluka and District-Tonk in the State of Rajasthan.

M/s Nayara Energy Ltd ie. the applicant vide letter No.2018/IN/Ahmadpura Chowki dated 20.06.2018 received in this office dated 02.07.2018 has submitted a proposal to this office on above captioned subject requesting us to accord final NOC for energizing the retail outlet. The proposal was forwarded to PD PIU NHAI Jaipur vide this office letter no. RW/JAI/RJ/PS/2016/638/3400-01 dated 03.07.2018 for comments and factual report and to submit completion certificate mentioning that the fuel station is neither in operation nor energized. PD PIU NHAI Jaipur vide letter No.23074/NHAI/JPR/J-T-D/NOC/Km.119.055/2018/2519 dated 05.12.2018 received in this office dated 10.12.2018 has submitted the required report. The proposal is granted "in-principle" approval and a provisional NOC by this office vide letter no. RW/JAI/RJ/PS/2016/638/2574-77 dated 02.08.2016. Since the proposal is granted "in-principle" approval on 02.08.2016 & more than two year lapsed in construction of retail outlet. Therefore this proposal may be considered through the extant policy of MoRTH i.e according to Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013 and accordingly Public comments (if any) are invited.


2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per Form A (copy enclosed) on below mentioned address.
