Invitation of public comments

Sub: Proposal for grant of access permission to a new retail outlet of M/s Nayara Energy Ltd (Formerly known as M/s Essar Oil Ltd) at Km.127.029 to Km 127.066 (Khasra No.754/15) on NH-758 at Village-Geta Paroli, Tehsil-Kotri, District-Bhilwara in the State of Rajasthan.

M/s Nayara Energy Ltd ie. the applicant vide letter even dated NIL received in this office dated 10.08.2018 has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. There exists a Kacha cart road on RHS (Opposite side of retail outlet) at a distance of 67m from the end of the retail outlet which has been agreed by PD PIU NHAI-Bhilwara. However the proposed retail outlet proposal is submitted in this office with a provision to construct service of 5.50m wide and 282m long as per the proposed drawing which will be constructed and maintained by oil company at their own cost and undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.


