

Nos.1247/2, 1247/2A, 1250, 1250/2, Orvakal Mandal, Kurnool District Andhra Pradesh abutting NH-40 @ Km.8/378-411 (Kurnool – Kadapa section) / Old NH-18 @ Km.348.124 (Kadapa – Kurnool section).

In this connection, it is submitted that the above proposal was examined and is satisfying the norms as stipulated in MoRT&H Circular No.RW/NH-33023/19/99-DI-III, dated.24.07.2013. The Private Property proposal submitted by M/s. Shankar Constructions & Developers, Kurnool has been inspected on 31.12.2018 and the inspection report is herewith enclosed.

The Owner of the Private Property has furnished the online payment receipt of bharatkosh.gov.in vide transaction no. 3112180002610, dated.31.12.2018 for Rs.10,000/- towards processing fee for the above proposal.

The applicant proposed to construct a 5.50m wide parallel service road with a length of 767.0m length {from Km.8/278 to Km.9/045 of NH-40 (New) / Km.347.457 to Km.348.224 of NH-18 (Old)} and extend the existing culvert at Km.8/600 (Old Km.347.902) at their own cost as per the norms of MORTH as shown in the layout plan and proposes to take access their property from the proposed service road only.

The Owner of the Private Property has furnished an undertaking that they will pay Rs.1.5 lakhs towards use of the National Highway Land whenever the demand raised by Highway Authorities in future. On approval of the proposal the license fee of Rs. 1.50 will be collected from the owner of private property.

It is certified that the License agreement submitted by the Private property has been compared verbatim with the MORT&H Circular No.RW/NH-33023/19/99-DI-III, dated 24.07.2013.

Since, the proposal under consideration is satisfying all the requirements as stipulated in the MORT&H circular no. RW/NH-33023/19/99-DI-III, dated 24.07.2013, it is herewith recommended for issue of in-principle approval to issue No Objection Certificate and access permission for approach road to private property of M/s. Shankar Constructions and Developers at Nannur Village, under Sy. Nos.1247/2, 1247/2A, 1250, 1250/2, Orvakal Mandal, Kurnool District Andhra Pradesh abutting NH-40 @ Km.8/378-411 (Kurnool – Kadapa section) / Old NH-18 @ Km.348.124 (Kadapa – Kurnool section).
