The Karnataka Urban Water Supply & Drainage Board (KUWS&DB), Bengaluru has sought NOC for laying sewer line along and across NH-207 from Km 55.620 & Km 57.380 of Sarjapura-Dabaspet section by KUWS&DB. Based on the request of Karnataka Urban Water Supply & Drainage Board (KUWS&DB) has inspected the site and verified the proposal with respect to Ministry's guide line and circular No.RW/NH-33044/29/2015/S&R(R) Dated 22.11.2016.After detailed examination the Executive Engineer has recommended for issue of NOC as per Ministry's guidelines.

The proposal received from the Executive Engineer has been examined with respect to Ministry's latest guide line vide No RW/NH-33044/29/2015/S&R(R) Dated 22.11.2016. The KUWS&DB proposed to lay the Pipeline at 9.00 to 10mtrs from Ch.56.80 to 57.300(Builtup aears) & 15.00 to 16.00 mtrs away from the Existing centre line of the Highway by open trench.

The request of the KUWS&DB to issue NOC for laying OFC cable is recommended here with subject to the following conditions.

- The Pipeline has to be invariably laid at a minimum distance of 15mtrs from the centre line of existing Highway. If the ROW is at a distance more than 15mtrs then pipeline has to be laid at the edge of ROW.
- While laying cable the guide lines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) Dated 22.11.2016.
- 3. In case of any future development by widening to 4/6lane the firm shall be replaced/shift the laid cables at their own cost within reasonable time of intimation given by the Highway Authority.
- 4. The approval may be communicated from NH point of view.

With the above conditions the proposal along with check list and necessary documents and drawings are here with enclosed and submitted with a request to communicate approval to issue NOC.
